- The Low Carbon Challenge Competition (the "Competition") is open to all members of the Eagles Ski Club (ESC)
- The Competition is not open to family members or anyone else connected to the Competition.
- Entry into the Competition is acceptance of these Terms and Conditions.
- To enter the Competition, you need to complete the survey, including your email address. You will then be automatically entered into the prize draw for this survey. - Anyone who completes the survey, and expresses a wish to enter the competition will be entered into the prize draw.
- The 2 randomly selected winners of the prize draw will receive either an orthovox transceiver from Facwest, or a £100 voucher from Backcountry UK.
- Only one entry per person per survey. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- The competition will run for 6 weeks, from Wednesday 1st September to the deadline for survey responses, midnight on Wednesday 13th October 2021. The winners will be privately notified shortly afterwards, and then formally announced at the ESC AGM on 5th November 2021.
- Neither **ESC**, or the businesses involved with the surveys or providing the prizes will rent, sell or lease this personally identifiable information to other companies or individuals.
